**Additional information** Insulated sandwich panel consisting of steel skins laminated over a core of expanded polystyrene. The E.P.S. is held in place by a two part polyurethane adhesive. The composition of BondorPanel is dependent on the product thickness (50mm to 300mm).

**RESPIRATORS:** In general the use of respirators should be limited and engineering controls employed to avoid exposure.
